 The undersigned has been appointed as Guardian ad Litem on behalf of the minor children, ______.

2. The Guardian ad Litem has learned that there may have been certain investigations initiated by the Lafayette County Division of Family and Children's Services of the Mississippi Department of Human Services [hereinafter: DHS] concerning some or all of these minor children.

3. The minor children are now at the center of a contentious custody dispute in this

Court.

4. The procedure for obtaining documents related to Department of Human Services records concerning minor children is governed by Rule 6 of the new Mississippi Uniform Rules of Youth Court Practice which provides the following procedures for the release of Youth Court and DHS records concerning minor children:

- (1) the party shall make an application to the court specifying which records are sought;
- (2) the court shall issue a subpoena duces tecum to the youth court for these records;
- (3) the youth court, unless a hearing is conducted pursuant to Rule6(b) of these rules, shall transfer copies of the records to the court;
- (4) **the court shall conduct an in camera inspection of the records,** in accordance with the procedures set forth in *Pennsylvania v. Ritchie*, 480 U.S. 39 (1987), to determine which records should be disclosed to the party;
- (5) the court shall, at all times, protect the confidentiality of the records to the extent required of the youth court under Mississippi's Youth Court Law.

Miss. Youth Court Rule 6.

5. Under these circumstances, the undersigned respectfully requests that this Court cause

to be issued a subpoena duces tecum directing the Youth Court of Lafayette County and the

Department of Human Services to produce the records concerning these minor children,

_____, to this Court for *in camera* review, so that this Court may

determine whether this information should be released to the Guardian ad Litem and the parties

in this case.

6. In addition, the undersigned respectfully requests such other general relief as may be

warranted in the premises.
