

#### INSTRUCTIONS FOR FILING A COMPLAINT

If you wish to file a complaint it will be necessary for you to complete the complaint form on the back of these instructions. Please read all instructions carefully before completing the form. List only one attorney per form and print or type in black ink. If your complaint is not properly completed it cannot be acted upon and will be returned to you.

PART ONE: You must give your name, address and phone number and the name and address of the accused attorney. This is particularly important where two people have the same or similar name. If you do not give the address, the complaint cannot be considered and it will be returned to you. If your address or phone number should change, notice should be given to the Bar immediately.

PART TWO: Your complaint will be considered even if you answer "no," but you must write in either "yes" or "no." If you do not, the complaint will be returned to you.

Write in "yes" only if someone has personal knowledge about the facts of the complaint. "Personal knowledge" is not gossip, rumor, hearsay, or just what is being said.

If you answer "yes," on a separate sheet of paper provide the names, addresses, ages, and phone numbers of those persons and state if they could come to Jackson, Mississippi to testify at any hearing. Also, if you answer "yes," send either a written statement signed by each person or tell in your own words what each person knows and how they got that information. If you do not send the names, addresses, phone numbers, ages, and statements, the complaint will be returned to you.

PART THREE: In section A, list by number, and give and description of each specific thing about which you are complaining. In section B, you are to make a statement of all the facts and details about what happened. To do so, write it down in chronological order; that is, start at the beginning and write things down in the order in which they happened. You may use extra sheets of paper, but make certain they are numbered. If you have letters, documents, or other evidence, you should send them along with your complaint. If you send such evidence, mention in your statement at appropriate places what evidence you are sending. This will help everyone to know what you are talking about.

PART FOUR: Please review your answers carefully. You must sign on the line above "Your Signature" and date the form. If your complaint is not properly completed it cannot be acted upon and will be returned to you.

PART FIVE: This is a certification that you have been provided with, have read and understand the information in the brochure that discusses how your complaint will be processed.

**OTHER INSTRUCTIONS:** The Mississippi Bar cannot tell you what to say in your complaint. You must write down the facts as you know them. However, if you need help to understand instructions, you can call (601)948-4471.

Your complaint will be reviewed, and if the Committee on Professional Responsibility finds it meritorious, it will be investigated. The Committee will notify you of the action it takes.

- Consult with opposing counsel in the scheduling of appearances, (3) meetings, and depositions.
- To treat opposing counsel in a manner consistent with his or her professional obligations and consistent with the dignity of the search for justice. As a professional, I will:
  - Not serve motions or pleadings in such a manner or at such a time as to (1) preclude opportunity for a competent response;

Be courteous and civil in all communications; (2)

Respond promptly to all requests by opposing counsel; (3)

Avoid rudeness and other acts of disrespect in all meetings including (4) depositions and negotiations;

Prepare documents that accurately reflect the agreement of all parties; and (5)

Clearly identify all changes made in documents submitted by opposing (6) counsel for review.

# As to the courts, other tribunals, and to those who assist them, I will aspire:

- To represent my clients in a manner consistent with the proper functioning of a (a) fair, efficient, and humane system of justice. As a professional, I will:
  - Avoid non-essential litigation and non-essential pleading in litigation; (1)

Explore with clients and opposing parties the possibilities of settlement of (2) litigated matters;

Seek non-coerced agreement between the parties on procedural and (3) discovery matters;

Avoid all delays not dictated by a competent presentation of arelient's (4) claims;

Prevent misuses of court time by verifying the availability of key participants for scheduled appearances before the court and by being (5) punctual; and

Advise clients about the obligations of civility, courtesy, fairness, cooperation, and other proper behavior expected of those who use our (6) systems of justice.

- To model for others the respect due to our courts. As a professional, I will: (b)
  - Act with complete honesty; (1)

Know court rules and procedures; (2)

Give appropriate deference to court rulings;

Avoid undue familiarity and any appearance or claim of any undue (3)(4) influence with members of the judiciary;

Avoid unfounded, unsubstantiated, or unjustified public criticism of (5) members of the judiciary;

Show respect with my attire and demeanor; (6)

Assist the judiciary in determining the applicable law; and
