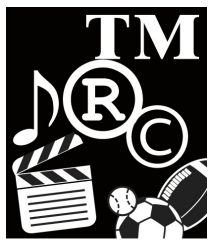

### About the Seminar

As transaction lawyers, especially intellectual property lawyers negotiating license agreements, we worry about many different issues, from protection of the intellectual property to what our support obligations or warranties might be. Bankruptcy is typically an afterthought. Yet, bankruptcy can have a profound (and often unexpected) effect on IP licenses. This webinar will provide some of the basics of how the law treats license agreements in bankruptcy (including special provisions for intellectual property) and some drafting tips to help your clients in the event of bankruptcy.
