### **About the Seminar**

Nicole McLaughlin will be providing an update on access to justice issues on behalf of The Mississippi Bar and the Access to Justice Commission, including new legal technology resources available to help low-income Mississippians access the state's civil courts and an upcoming statewide legal clinic initiative that will take place in June 2018.
