If you have not had an opportunity to review the Bar's website recently, please take a few moments to do so. There, you will find a dedicated page to **COVID-19 Court and Operations Updates**, that provides direct links to Emergency Administrative Orders issued by the Mississippi Supreme Court, the U.S. Supreme Court, the U.S. Court of Appeals – Fifth Circuit, the U.S. District Courts for the Northern and Southern Districts, the U.S. Bankruptcy Courts for the Northern and Southern Districts, various Circuit, Chancery, Youth, and County Courts, and the MS Workers Compensation Commission. This dedicated web page also contains Practice Management and Remote Work Resources for Member Benefits and Discounts, Legal Ethics and COVID-19 information, Safety and Wellness Tips, and

Federal and State Government Updates. This page can be accessed by clicking on the "For Members" tab at the top of the home page of msbar.org. From there, scroll down to "COVID-19 Court and Operations Updates."

In addition, the Bar's webpage has other helpful information and tools for members, and some general information for the public, as well. You will find access to the Lawyer Directory, Fastcase, publications, CLE information, and educational information regarding Ethics and Discipline, just to name a few of the member resources. The general public can find educational information regarding legal terms and procedures, the court structure, how to select a lawyer, and other consumer information. This is a wonderful tool for the legal profession and should become an integral part of our law practices as we navigate the days ahead.

Ethical and Wellness Resources

During these very different and sometimes challenging times, it is important to remember that our ethical responsibility to the public and to our profession remains. All of the Mississippi Rules of Professional Conduct (MRPC) and Ethics Opinions apply to our practices whether those be traditional, in-person practices or remote practices. Please review the Rules of Professional Conduct and remember that as attorneys and counselors at law we are ethically obligated to exhibit Competence (MRPC 1.1); maintain our clients' confidences (MRPC 1.6); keep our clients reasonably informed about their legal matters and communicate with them about their legal matters (MRPC 1.4); and show fairness to the opposing parties and counsel-opposite (MRPC 3.4). Certainly, maintaining the integrity of IOLTA Trust Accounts is paramount in these times of financial challenges. PLEASE review MRPC 1.15, which "imposes strict fiduciary standards on every Mississippi lawyer who holds the property ("trust funds") of clients or third parties. Mishandling trust funds, whether intentional or not, is "the cardinal sin for lawyers." Miss. Bar v. Coleman, 849 So.2d 867, 874 (Miss. 2002) (emphasis added)." See msbar.org: "Lawyer Trust Account Guidelines" and "Legal Ethics and COVID-19" which set forth ethical obligations in a time of pandemic.

Changing any aspect of how we practice law and represent our clients can be incredibly stressful and anxiety-ridden. It is imperative that we all maintain our health and wellness. Where there is Crisis, Opportunity Appears

As evidenced by the tremendous member response to the virtual Annual Convention this past year, change, while seemingly frustrating and disappointing, can offer silver linings if we choose to look for and see them. The 2020 Summer School and Annual Meeting attracted over 900 registrants. This is more than double the number of attorneys who have traditionally participated in the Annual Convention activities.

Committee participation has also greatly increased as a result. This year, instead of one single Committee Day at The Hilton in Jackson, we scheduled a Committee Week in which 15 of our committees had their initial meetings of the year over four days. Because of the expanded schedule, I was available to participate in at least part of each meeting.
