Award Guidelines

Distinguished Service Award

This award shall be granted to a lawyer or lay person for outstanding achievement in or a significant contribution to the legal community beyond his or her normal job duties. The recipient must be cited for specific actions which occurred no longer than three (3) years immediately prior to the date of the award. The Distinguished Service Award is presented annually.

Lifetime Achievement Award

This award will be granted for devoted service to the public, profession and administration of justice over the span of a professional career. Only lawyers or individuals who have worked within or contributed significantly to the system of justice will be qualified to receive this award. The Lifetime Achievement Award is presented only on those occasions when a deserving recipient is nominated and selected.

Judicial Excellence Award

The Judicial Excellence Award recognizes an exceptional judge who is an example of judicial excellence, a leader in advancing the quality and efficiency of justice and a person of high ideals, character and integrity. To be eligible, a judge must be a full time, sitting judge. Judges on senior status are eligible if they continue to be active on the bench.

Nominations shall be reviewed by the Executive Committee of The Mississippi Bar. The Executive Committee shall make its recommendations to the Board of Commissioners. Upon approval of the Board, award recipients shall be notified by the Executive Director of the Bar. All awards shall be presented at the next Annual Meeting of the Bar following their selection by the Board of Commissioners.
