The award is presented annually to a living woman meeting the following criteria:

- The individual achieved professional excellence in her field **AND** also influenced other women to pursue legal careers, **OR**
- Opened doors for women lawyers in a variety of job settings that historically were closed to them, **OR**
- Advanced opportunities for women within a practice area or segment of the profession.

Nominations shall be reviewed by the Susie Blue Buchanan Subcommittee of the Women in the Profession (WIP) Committee of The Mississippi Bar. The Subcommittee will select and contact the award recipient. The Susie Blue Buchanan Award will be presented at the 23<sup>rd</sup> Annual Price-Prather Luncheon of the Women in the Profession Committee at The Mississippi Bar Convention in Destin, Florida.
